1. RULES

- 1.1. The event is governed by the rules as defined in *The Racing Rules of Sailing (RRS)*. The Prescriptions of the RNWA can be found at: world Sailing-Racing Rules of Sailing
- 1.2. The 'Rules for (Open) Championships Sailing, Windsurfing and Kiteboarding' will apply
- 1.3. The following racing rules will be changed: RRS A 2.1 (see NoR 13). The sailing instructions may change other rules as well.
- 1.4. If there is a conflict between languages the text in the English language will take precedence.
- 1.5. Every person on board who has his domicile in the Netherlands shall have the appropriate license.

3.1. Notices to competitors will be posted on the official notice board(s) adjacent to the race office.

4. ELIGIBILITY AND ENTRY

- 4.1. The event is open to all boats of the Solo class.
- 4.2. Boats may enter the event by registering online on the Dutch solo class website no later than the 1st of September 2025. The required fee(see also NoR 5 and 24.2) shall be paid during the entry procedure.
- 4.3. To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.



4.4. Entrees later than 1st of September will not be admitted to this ODC

5. **FEES**

15. SCORING

- 15.1. Four races are required to be completed to constitute a championship.
- 15.2. a) When fewer than 5 races have been completed, a boat's series score be the total of her race scores.
 - b) When 5, 6, 7 or 8 races have been completed, a boat's series score will



- be the total of her race scores excluding her worst score.
- c) When 9 or 10 races have been completed, a boat's series score will be the total of her race scores excluding her two worst scores.

This changes App A 2.1

21. DISCLAIMER OF LIABILITY / RISK STATEMENT

- 21.1. RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.
- 21.2. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
- 21.3. Sailing is by its nature an unpredictable sport and therefore involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:



- (a) they are aware of the inherent element of risk involved in the sport and accept
 - responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- (b) they are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- (c) they accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- (d) their boat is in good order, equipped to sail in the event and they are fit to participate;
- (e) the provision of a race management team, patrol boats, and other officials and volunteers by the event organizer does not relieve them of their own responsibilities;
- (f) the provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances:
- (g) it is their responsibility to familiarize themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event;
- (h) they are responsible for ensuring that their boat is equipped and seaworthy so as to be able to face extremes of weather; that there is a crew sufficient in number, experience and fitness to withstand such weather; and that the safety equipment is properly maintained, stowed and in date and is familiar to the crew.

22. INSURANCE

22.1. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of €1.500.000 per event or the equivalent.

23. **PRIZES**

23.1. The RNWA supplies for the winning boat or team a blue pennant and a medal for every member of the crew of the first three boats or crews.



23.2. Other prizes may be given.
